### Defend Yourself: Medlegal Topics in EMS

Most of us groan when we hear about medical legal issues and practices. But we also know how crucial it is to our own livelihood to make sure we do what's right or what's best for the patient. Trouble is, most of us don't know what the best approaches are to practicing clinically excellent medicine in a legally defensible manner. That's why this workshop is a "must attend" for pre-hospital care personnel.

We will cover topics that will help you be more aware and have a better understanding of what to do, and not do, in your daily practice.

We will demonstrate

- how documentation can save or hang you
- explain the anatomy of a lawsuit and how to minimize your liability
- highlight principles to follow when making critical decisions about a patient's care or transport

Discussion and case studies will provide participants the opportunity to get answers to their questions. The highlight of the workshop will be a mock trial where real judges and attorneys will demonstrate how lawsuits are fought, won or lost in the courtroom.
